## **Background**

#### Summary of provider and management structure:

- Eastern College Australia Inc was initially registered as an RTO in August 2008.
- The organisation is also a Higher Education provider registered under TEQSA Provider No. PRV12149. In May 2020 TEQSA approved the organisation to offer higher education courses to overseas students at the Wantirna campus under CRICOS Provider Code 03853H.
- The organisation offers courses in Christian Foundations, Aid & Development, Community
  Development, Counselling, Education, Social Sciences and Youth Work from Certificate III through to
  Masters level.
- The organisation is registered with the Australian Charities and Not-for-profits Commission and governed by a Board of Directors.
- The organisation structure of the RTO comprises of:

# Minor deficiencies

During the course of the audit, some minor deficiencies were noted. These were not significant such that they resulted in a finding of non-compliance against the relevant clause. They were however discussed with the provider and the provider agreed to remedy these. This included:

• There is a lack of information about the Tuition Protection Service in the written agreement and the Overseas Student Handbook.
